**Deposit:** Deposits shall be submitted annually with the storage agreement. If a timely payment is not made, the Company may reassign space and terminate this contract without notice. A deposit of **\$500.00** is required to hold space and is due by **June 1st**. Refunds of storage deposits will not be made after **June 1st**.

Drummond Island Yacht Haven, Inc. ("Company") recommends that the owner's remove from boat all personal property during winter storage or when the boat is left with the Company for purposes of storage. *The Company does not carry insurance on owner boat and contents during storage or when on company premises.* Owner is advised to carry insurance covering owner boat and its contents against risk of every kind, including theft, vandalism, malicious mischief, fire, wind, water, or act of God. Due to the number of persons using waterfront areas, the Company regrettably is unable to exercise control or supervision over individuals other than Company employees who may come onto the Company premises or may use the grounds adjacent thereto. Accordingly, it is mutually agreed that the Company's liability for personal injury or property damage shall be strictly limited to the negligence or wrongful act of the Company and its employees. Company premises is not fenced and may not be locked. No guard service is provided.

OWNER has read this entire storage agreement and understands and agrees to the terms and conditions. Owner affixes his/her signature below agreeing to this **Contract** with **Company** for storage services for the storage season. Storage charges are due 30 days after billing date. A late fee of 1.5%/month will be charged on all past due billings. **Notice:** a lien is created under the Michigan Marine and Boatyard Storage Lien Act 362 of 1998 if owner fails to pay storage and other charges on the boat listed above. Notice of lien will be recorded with the USCG National Vessel Documentation Center for documented boats.
